SUBJECT: Joint Reserve Intelligence Program (JRIP)

1. PURPOSE

Under the authority vested in the Secretary of Defense by reference (a) and pursuant to references (c) and (d), this Directive establishes the Joint Reserve Intelligence Program (JRIP) and authorizes the issuance of instructions and guidance for the implementation of this Directive.

2. APPLICABILITY AND SCOPE

This Directive applies to the Office of the Secretary of Defense, the Military Departments including the Reserve components, the Chairman of the Joint Chiefs of Staff, the Combatant Commands, the Office of the Inspector General of the Department of Defense, the Defense Agencies and the DoD Field Activities (hereafter referred to collectively as "the DoD Components").

3. DEFINITIONS

3.1. The Joint Reserve Intelligence Program (JRIP). The JRIP supports wartime readiness and peacetime requirements for intelligence collection, analysis, production, and dissemination by fully utilizing the intelligence elements of the Reserve components (RC). In doing so, the JRIP engages RC intelligence assets during periods of active and inactive duty to support validated DoD intelligence requirements across the entire engagement spectrum from peacetime through full mobilization, coincident with wartime readiness training.

3.2. Reserve Components. Refers collectively to the Army National Guard of the United States, Army Reserve, Naval Reserve, Marine Corps Reserve, Air National Guard of the United States, Air Force Reserve, and Coast Guard Reserve, when the Coast Guard is operating as a Service of the Department of the Navy.

4. POLICY

4.1. It is DoD policy:

4.1.1. To ensure the RC intelligence force is fully integrated during all periods of active and inactive duty in meeting peacetime through wartime DoD intelligence requirements, coincidental with wartime readiness training.

4.1.2. For the RC to encourage and promote the use of DoD facilities, capabilities, and services during periods of active and inactive duty to support the peacetime through wartime requirements of the Department of Defense so as to concurrently sustain or enhance the wartime readiness of the RC.

5. RESPONSIBILITIES

5.1. The Assistant Secretary of Defense for Command, Control, Communications, and Intelligence (ASD(C3I)) is the principal staff assistant and advisor to the Secretary and Deputy Secretary of Defense for the JRIP and shall exercise intelligence policy, guidance and oversight for the JRIP within the Department of Defense. The ASD(C3I) shall:

5.1.1. Establish a Flag/General Officer Steering Committee (GOSC) to routinely assess the JRIP and provide status reports and recommendations on its continued development and implementation.

5.1.2. Assess the effectiveness of the JRIP in supporting DoD intelligence requirements.

5.1.3. Ensure cross-Service coordination and cooperation with regards to management of the JRIP to enhance interoperability within the Department of Defense and with other Federal Agencies.

5.1.4. Provide assistance to the DoD Components on matters relevant to the execution of their assigned responsibilities regarding the JRIP.

5.1.5. Serve as the principal DoD official responsible for planning and defending the JRIP before the Congress. The ASD(C3I) shall exercise this authority in conjunction with the Defense Intelligence Agency (DIA).

5.1.6. Participate in the DoD Planning, Programming, and Budgeting System (PPBS) for JRIP activities.

5.1.7. Coordinate with the Assistant Secretary of Defense for Reserve Affairs, as appropriate, in the exercise of assigned responsibilities in references (c) and (d), above.

5.1.8. Assign to the Director, DIA, program management responsibilities for the JRIP to include: implementation planning, execution, and integration of the JRIP throughout the Department of Defense; identifying, developing, implementing, and maintaining common JRIP capabilities for improved efficiency and effectiveness; and preparing periodic progress reports for ASD(C3I) review.

5.2. The Assistant Secretary of Defense for Reserve Affairs ASD(RA) is the principal staff assistant and advisor to the Under Secretary of Defense for Personnel Readiness (USD(P&R)) and the Secretary and the Deputy Secretary of Defense for RC matters within the Department of Defense and is responsible for overall supervision of all DoD RC affairs. The ASD(RA) shall review, evaluate, and oversee the Services' RC in their support of the JRIP.

5.3. The Assistant to the Secretary of Defense for Intelligence Oversight (ATSD-IO), in accordance with references (b), (e), and (f), shall be responsible for independent oversight of all intelligence, intelligence-related activities, and counterintelligence activities conducted by RC intelligence forces.

5.4. The Chairman, Joint Chiefs of Staff shall ensure that RC intelligence forces are fully integrated into peacetime through wartime intelligence operations and missions, coincidental with wartime readiness training.


5.5. The Secretaries of the Military Departments and the Heads of the Other DoD Components shall:

5.5.1. Ensure that JRIP-assigned RC intelligence forces are fully integrated into peacetime through wartime intelligence operations and missions, coincidental with wartime readiness training.

5.5.2. Ensure that JRIP-assigned RC intelligence forces have access to JRIP sites and infrastructure to meet validated intelligence requirements of the Department of Defense, peacetime through full mobilization.

6. EFFECTIVE DATE

This Directive is effective immediately.
